# PHOTO and other MEDIA RELEASE and WAIVER FORM



*For use on the Brookline Public Library Web Site  
And/or for Library Program Promotion*

All photographers taking photographs, video or using any other recording device(s) at a Brookline Public Library event are required to obtain a signed release from any attendee who is visibly recognizable in the photograph or can be otherwise identified .

These rules govern photographs and other forms of media intended for use in any Brookline Library publication of a marketing or a public relations nature, such as newsletters, brochures, viewbooks, promotional items, or other such material. Releases also must be obtained for photographs or other media used on a web site. These rules are not in effect when photographs or video recordings are taken of news events, but photographs or video taken for news purposes require a release for reuse in marketing materials.
